

## Governance Reform Report

### 1. Introduction

Following the approval of the governance reforms by the AGM in November 2022, the Board and its Governance Working Party have been working on the implementation of the reforms and a wide range of constitutional and governance documents.

The first phase of Committee Terms of Reference and various Rules of Procedure was approved at the Annual Conference in November 2023.

The second phase of the reviewing/rewriting of the Regulations was completed in May 2024 at the Mid-Year Council meeting.

The Governance Working Party now proposes the third and final phase of work with the proposed regulation/policy split for the following Regulations:

23	Olympic Sailing Competition
27	World Rankings
28	Racing Rules Administration
29	Equipment Rules Administration
30	Equipment Rules Administration
31 – 34	World Sailing Race Officials

As before, all Committees were consulted on the proposed split of Regulations and Policies.

Amendments to Regulation 23 (renamed Regulation 11) have been considered in depth with the Regulation 23 Working Party and by the Board. There are no substantive changes proposed to the system of making 'Event' and 'Equipment' decisions.

The Governance Working Party is not proposing any amendments to the Advertising Code, Anti-Doping Code, Eligibility Code, and Sailor Categorization Code. These will be retained as written, however they are attached in this phase as they contain amendments to the numbering, so they become stand-alone documents. For example, the Advertising Code is no longer Regulation 20.

The Code of Ethics, Disciplinary Regulations 35 and the Betting and Anti-Corruption Code are being consolidated into one single Code of Ethics and this appears as a separate agenda item.

As per the original proposals a full review of Council Minutes dating back to 2011 has taken place in order to create the Policy Register.

The Policy Register covers seven areas:

Policy A – General

Policy D – Equipment

Policy E – Events

Policy J – Oceanic & Offshore

Policy K – Para Sailing

Policy L – Race Officials

Policy N – Regional Games

As Council will recall, policies no longer need to be in the Regulations. The new governance structure is aimed at being more flexible, more responsive and better able to change policy to meet the growth in our sport.

**2. The Timeline of the Governance Reform**

- (a) November 2022 Governance Reforms -Approved.
- (b) November 2023 Phase 1 – Terms of Reference for all Committees and Sub Committees and Rules of Procedure, Council and General Assembly-Approved
- (c) May 2024 Second Phase of Documents Approved.
- (d) November 2024 Final phase 3 proposed to Council.
- (e) At the end of the General Assembly the 2024 Constitution comes into effect. New Isle of Man Company Registered. All new Regulations and documents are in effect.

**3. Recent Changes**

As you will recall in July 2024 World Sailing proposed amendments to the new Constitution to make changes to the Equity, Diversity & Inclusion Committee, Specialist Sailing Committee, Olympic Classes Sub Committee and at the same time made a number of minor amends and clarifications. These were approved by way of circular resolution.


